<u>C Kent Minerals and Waste Local Plan 2024-39</u> Pre-Submission Draft (Regulation 19) Public Consultation

The Kent Minerals and Waste Local Plan sets out the strategy for the sustainable management of Kent's waste and supply of minerals and is the primary element of the development plan for Kent against which planning applications and appeals for minerals and waste development in Kent will be determined.

Once adopted, the Kent Minerals and Waste Local Plan 2024-39 will update the adopted Kent Minerals and Waste Local Plan 2013-30 (as amended by the Early Partial Review (2020)). The County Council is now seeking views on the soundness and legal compliance of the Pre-Submission Draft of the Kent Minerals and Waste Local Plan 2024-39.

The consultation is being carried out under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012 and is an opportunity to comment on the document before it is submitted to the Secretary of State for Independent Examination. Any views received will be forwarded to the Secretary of State for consideration as part of the Independent Examination.

The consultation is taking place from Wednesday 17th January 2024 to midnight on Thursday 29th February 2024.

10. Hever Road Shops

To be able to obtain quotes for works that Members wish to be carried out, guidance with a specification is first of all asked of Members. There are three possible options for this work.

Option 1

Fill in holes left from removal of dead trees and lay matching paving on top.

Option 2

Excavate roots to best ability (pulling up surrounding slabs) fill with aggregate and pave over

Option 3

Excavate large area to cover root area to protect subsidence, lay reinforced concrete slabs/raft and lay paving slabs to cover.

Contractor to check and be aware of any services in the area

Members discussed the works required and it was proposed by Cllr McCarth and seconded by Cllr Bennette to obtain quotes on option 3. The Clerk would send the spec to Contractors and come back to Council with quotes.

11.Paving - in front of the library and to the side of Pavilion.

The paving slabs outside the library are no longer level and t has been reported could cause a trip hazard.

The paving along the side of the pavilion which was re concreted just before covid has broken and now has an uneven surface.

Members are asked to look at the areas before the meeting and discuss the options to improve these areas.

A specification and quote was given by Cllr Seal to the Chair. It was agreed to obtain advise as to what would be best for the area. the Clerk will then be able to go to contactors to quote for works when a specification was agreed.
